Pebbles is currently supporting children aged 0 – 18 and their families in the farming communities in Somerset West, Stellenbosch, Paarl, Wellington, Hemel-en-Aarde valley in Hermanus and Citrusdal. The majority of our beneficiaries are children of wine farm workers who live on the various farms in often challenging circumstances. Alcohol abuse, poverty, lack of access to education, health and other essential services all contribute to the reason why Pebbles exists.
